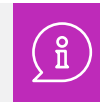
## Mobile Signature Capture

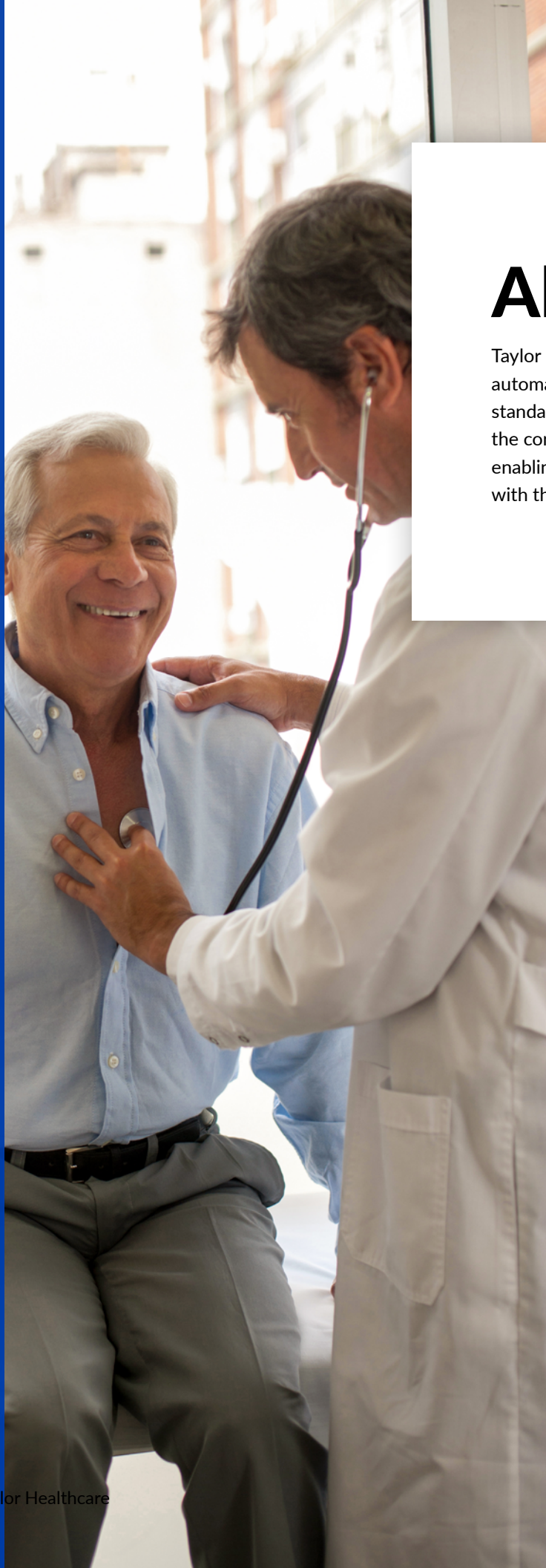
